## 1. Enrolments & Equipment

- The time slot allocated to your child will be for the duration of the school term.
- By enrolling you are agreeing to attend/pay for a full school term's coaching. All necessary equipment can be ordered through your CF tennis coach/ CF office
- One set of registration forms must be completed per child. Please be sure to initial, sign and submit both the pages to CF tennis - [admin@cftennis.co.za](mailto:admin@cftennis.co.za). Coaching will not commence until this is received.
- When there is school, there will be tennis.

## 2. Payment & Notice Period

- Accounts will be emailed to you in the 1st two weeks of each term. Invoices are payable on receipt.
- A cash deposit fee will be charged for any cash deposits into the CF tennis bank account.
- Unless written alternative arrangements are made by the signatory, all outstanding accounts will be handed over on the last day of term.
- Termination of lessons - One month's written notice is required and paid for.
- Interest will be charged at 10% per month on outstanding accounts.

## 3. Private Coaching terms

- A private coaching lesson consists of 1 player.
- Any lessons cancelled by CF Tennis will be made up during the course of the term, failing which the lesson (s) will be credited.
- If a Private lesson is missed due to inclement weather, a reasonable attempt will be made to make up the lesson, failing which 50% of the fee will apply.
- In the event of rain on a training day, private lessons will be held indoors where all necessary theory will be discussed. This is essential knowledge to assist in the client's learning experience. Failure to attend any indoor lesson without notice will result in no make-up lesson being offered.
- If 24hours notice given for the cancellation of a private lesson, the lesson will be made up during the course of the term.
- If less than 12 hours' notice is given for the cancellation of a Private lesson, the lesson will be forfeited.
- Any make up lessons need to be made up during the term or, the 1st week of the holiday. Failing which, these lessons will be forfeited.
- Credits must be made up during the calendar term or year that the lessons were booked and paid for.
- NO credits will be carried forward to the following term or year for any lessons missed.
- NO refunds are given for any lessons missed by the pupil
- If you are away or intend being away you will not receive a credit, unless due to unforeseen circumstances (such as serious injury or illness)

## 4. Semi-Private and Group Coaching terms- Billed per term

- A semi-private session consists of 2 players
- A group lesson consists of 3-6 players
- No refunds or make-up lessons will be given for non-attendance of a semi-private or group lesson.
- In the event of rain on a training day, group lessons will be held indoors where all necessary theory will be discussed. This is essential knowledge to assist in the pupil's learning experience.
- If this is not possible, 50% of the fee will apply.
- Parents will forfeit the lesson if they withdraw their child for whatever reason (too hot, too windy, too wet etc.)
- Should lessons be missed, for whatever reason, no make-up lessons are applicable

## 5. Squads

- Squads will be billed per term and are by invite only
- Squads are for the children who are competing in tournaments
- If you miss more than 3 sessions during a given term, your position in the squad will be given to the next person on the waiting list

## 6. Agreement

- By enrolling with CF Tennis you agree to the terms and conditions outlined in this document.
- CF Tennis reserves the right to modify these terms and conditions.

## 7. Communication

- All communication is done via email, what's app and sms's. Please provide the relevant email and cell number for the person involved with enrolling your child for tennis lessons.
- All information received by CF tennis will be confidential and will only be used for CF tennis's communication purposes.

## 8. Termination

- Termination of your child's tennis lessons is subject to one calendar month's written notice, via email, and payment thereof.

CF Tennis, their successors, assigns, subsidiaries, associates, affiliates, officers, directors, employees, agents and contractors (the "indemnified parties") shall not be liable to any entrant, participant or his or her dependants for any injury, damages, loss, claim, judgment, or *other* liability or expense (including, but without limitation, direct, indirect, incidental, special or consequential loss or damage of any kind whatsoever or howsoever caused) whether arising under contract, delict or otherwise and whether the loss was actually foreseen or reasonably foreseeable of whatever kind or nature, including whether for death, personal injury, property damage, or theft, that may be sustained as a result of the use of this service or that may arise before, during or after participation in any of the CF Tennis events or any recommended programmes for such events and the entrant indemnifies the indemnified parties against all such claims that may be brought against them in this regard. Persons accepting this waiver and indemnity on behalf of other persons or in their capacity as parent or legal guardian of a minor hereby agree to such persons or minors being bound by the foregoing and hereby further indemnify the indemnified parties against any claims brought against them by any such persons or minors.
